INTRODUCTION

Colombo International Container Terminals Ltd., (CICT) is a joint venture between China Merchants Holdings (International) Co., Ltd. (CMHI), a blue chip Company listed in the Hong Kong Stock Exchange, and the Sri Lanka Ports Authority (SLPA). It is a 2.4 million TEU capacity terminal in the Port of Colombo, constructed under a 35 year Build, Operate and Transfer (BOT) agreement. The largest shareholder of this Company is CMHI with 85% ownership and the balance 15% is held by SLPA.

CICT commenced construction of the terminal in December 2011. With an envisaged investment of US\$ 500 million, including the proposed installation of the latest state of the art terminal equipment, it is so far the single largest Foreign Direct Investment in Sri Lanka by a private entity.

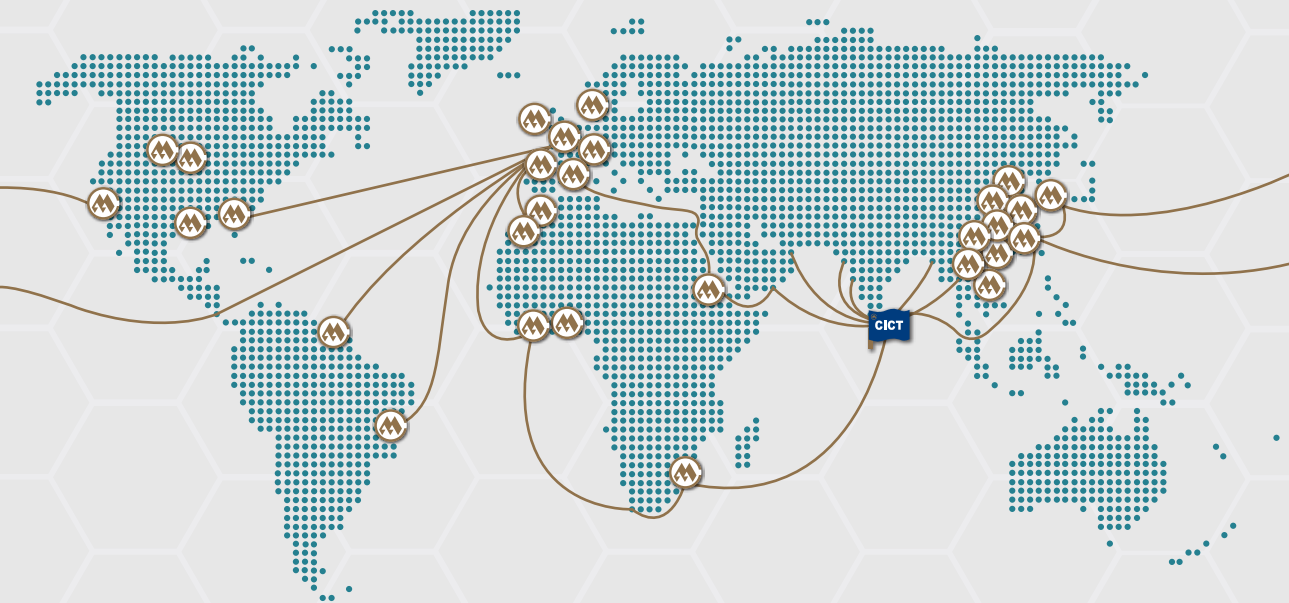
